## Strategies for volatile markets

The graph below shows how a hypothetical $\$ 100,000$ investment in stocks would have been affected by missing the market's top-performing days over the 20 -year period from January 1, 2003 to December 31, 2022. For example, an individual who remained invested for the entire time period would have accumulated $\$ 647,854$, while an investor who missed just five of the top-performing days during that period would have accumulated only $\$ 409,182$.

## Stay invested: Missing top-performing days can hurt your return
